## **APPENDIX 1: CRAFT ENTRY PERMIT ISSUANCE PROCESS**

- 1. Craft owner/operator shall seek ADNOC Ship Vetting Department acceptance.
- 2. If inspection is necessary, ADNOC Ship Vetting Department will provide Craft owner/operator with:
  - a) Ship Inspection terms & Conditions
  - b) Craft Entry Permit Form
- 3. Owners shall Return the following by email before inspection is arranged:
  - a) Accepted Ship Inspection terms & Conditions.
  - b) Completed Craft Entry Permit form in both word format and signed/stamped pdf.
  - c) Signed/stamped Conditions of use for Crafts involved in Marine Projects.
  - d) Copy of statutory certificates as listed in section 2 of the form.
  - e) Copy of CICPA security pass (if already issued).
- 4. Craft owner/operator shall make copy of the above (2 & 3) available onboard for the inspector.
- 5. Vetting inspector during the inspection will check and verify the validity of all Statutory certificates as listed in Section 2 of the Craft entry permit form.
- 6. Upon completion of assessment and if accepted, ADNOC Ship Vetting Department will advise the Owners with a copy to Harbour Master of the confirmation on acceptance of the vessel indicating the validity of acceptance.

<u>Note</u>: If the vessel is subject to a follow-up inspection, copy of all the certificates as listed in Section 2 of the form shall be updated during the follow-up inspection.

- 7. Upon issuance of the CEP, The Harbour Master shall issue the debit note for the administration fee to the owners, The validity of the (CEP) shall be in line with earliest date of :
  - a) Vetting Acceptance validity date, or
  - b) Expiry of any of statutory certificate
- 8. If a vessel has renewed any statutory certificate, a copy of only the renewed certificate shall be sent to ADNOC Vetting along with a fresh application.
- 9. Upon expiry of the CEP due to expiry of the vet validity, craft operators would have to depart the port or apply for a fresh inspection / renewal.
- 10. If a change in project assignment takes place within the validity period of the CEP, only new application form is to be completed and sent to ADNOC Vetting. (No administration fee)
- 11. If a vessel departs from a port and returns or move between ports for whatever reason within the validity period of the CEP, vessel need not re-apply for a permit.
- 12. A valid craft entry permit issued for an offshore port shall be considered valid for an onshore port and vice versa.
- 13. Crafts holding valid CEP, may become subject to inspection by the Port Authority, during their stay within the port limits.

## Note:

The issuance of CEP is conditional to no negative feedback by the OPCO/Port Authority during the project.
